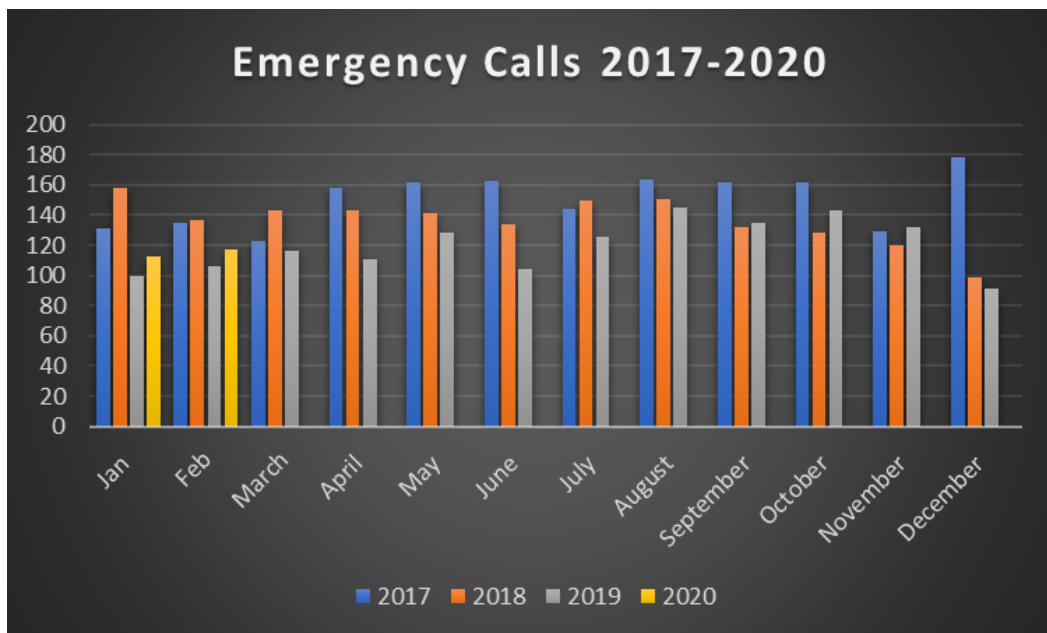
### Staff Report

The mission of the Tubac Fire District is to create a safer environment within our community in order to increase the quality of life which our citizens may enjoy.

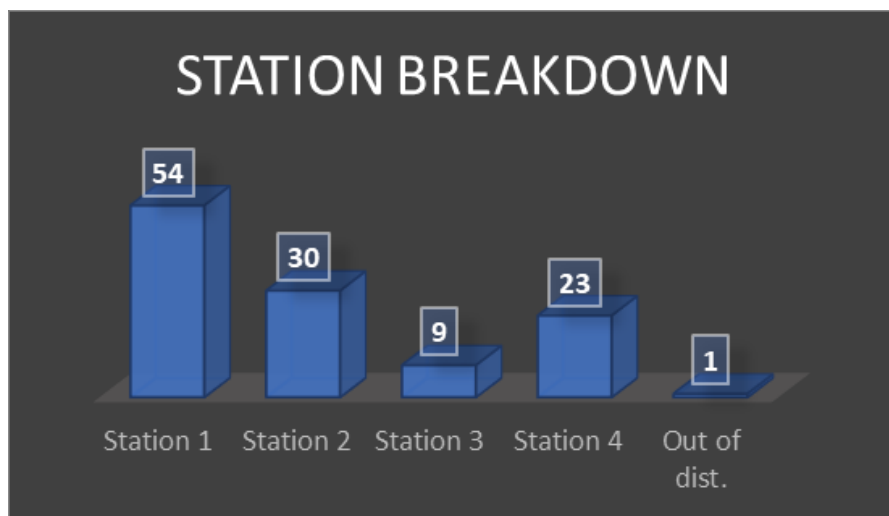
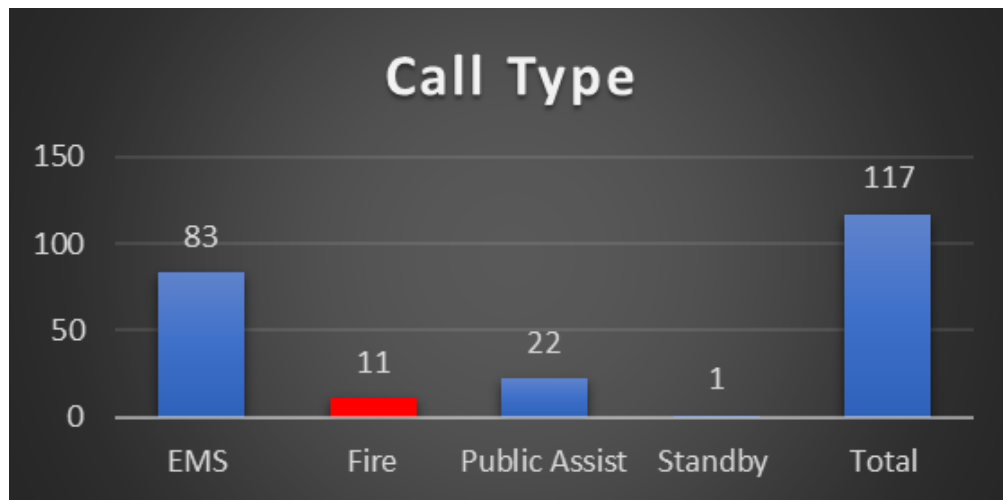
#### Operations Update

February 2020 Data



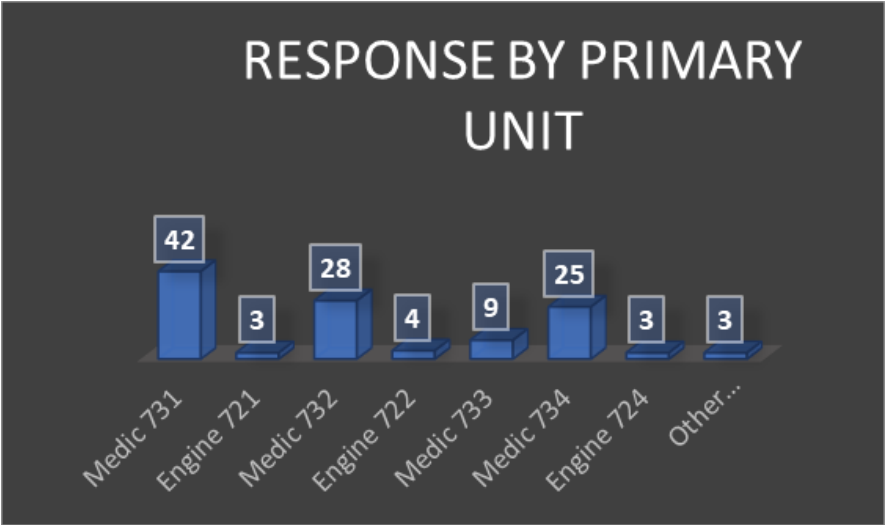
The above chart reflects unique incidents by station, not total number of unit responses. For example for a motor vehicle accident (MVA), more than one TFD unit will respond to the call, which is tracked as one unique incident for the primary responding unit.

Station 2 – Average 51 unique incidents per month

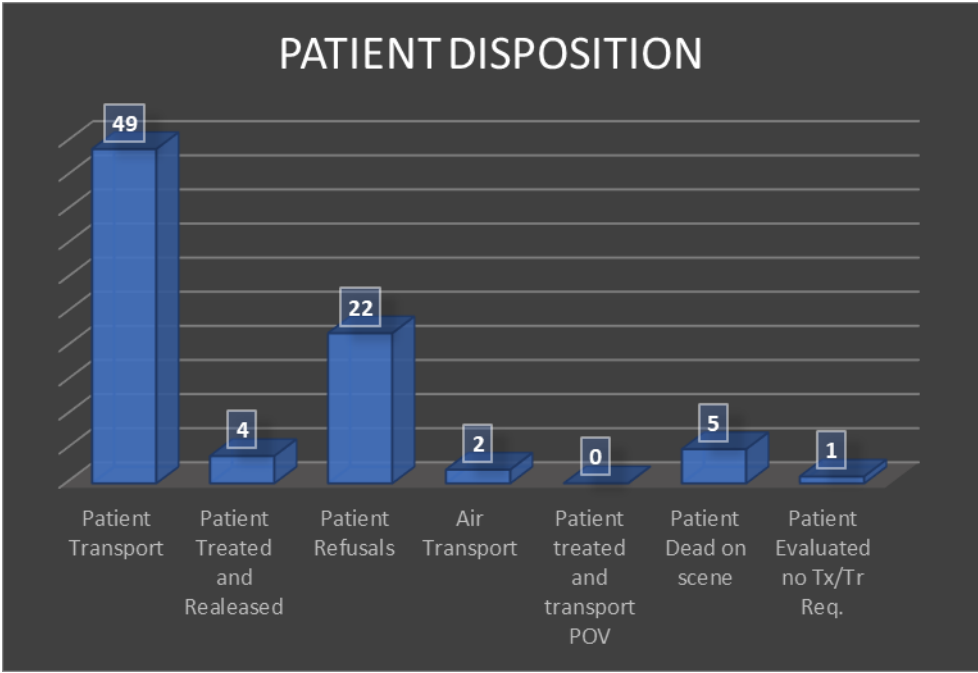
Station 3 – Average 10 unique incidents per month

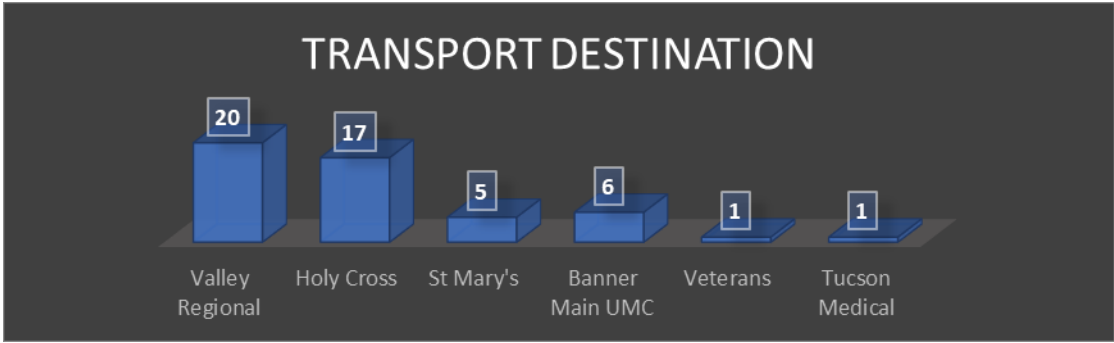
Station 4 – Average 19 unique incidents per month
